Construction of the room is in progress.

Chiefs Report: July to August

State MOB: This years has been twice as busy as last year, year to date over \$14,000 and counting.

Rudy has attended his first MOB fire and would like talk about it.

We had to cancel the officers meeting for this month due to many officers out of the area.

Still looking for an antenna for the new repeater site, we just missed out on one from GSA they will try to find another one next week for us.

Colmac tender lunch in will be held at 11 tomorrow not 11:30 all fire commissioner are welcome along with fire fighters who help work on it.

We need to clarify our districts red card qualification standards so everyone is on the same page.

We are also changing our radio protocol and hope to have all fire fighters on the same page by the end of the month.

I'm in the process of changing the vehicle radios narrow band by the end of the year to be in compliant by 2013

Medical Officer's Report: I see the EMS levy passed so I do have some ideas for using some of those funds. We could use an airway practice manikin (\$650-\$1900) and we need an up-to-date heart monitor for 3845 (\$5000). We will eventually be looking at one more 4wd ambulance to be stationed in Orient.

Alex Sechrest needs to take his National EMT Certification test.

MOTION, Wooten, to approve \$5000 to purchase a new/refurbished heart monitor. If over \$5500, excess expenditure must be approved by the board. Seconded, Dechant m/s/p
