Chief's Report: Chiefs Report May to June 2014

"Let's start off with grants, the 2013 DNR grant is coming to a close here soon, they will need more info regarding the grant and in kind labor. But unfortunately we did not keep track of in kind very well and will see some deduction in the actual grant amount. As for the two FEMA grants, we have not received any termination or award letters.

The 1962 diamond t pumper has sold for \$3,800 dollars, I sent the title and Peter was issued the check. I would like the commissioner to make a motion to surplus the 1985 Ford Ambulance, since this vehicle was donated to the district I would like to pay it forward to any Stevens' country fire districts. If no one is interested then the unit will be put up for sale.

I have had several people comment on the flag we displayed at Town and County days, Kettle Falls would like to thank the commissioners for its use.

The maintenance building is coming along quitewell thanks to the efforts of Rudy and Robert, great job guys. I hope to have some more people help out with the roof here in a couple of weeks.

I need approval to purchase three more Icom pager / radios, I have three radios that quit receiving page outs and Greg G lost his radio during the Boyd's fire. I will see if they can be repaired. At this time we have no extra radios in stock. Looking at \$1200 for the three radios.

The training officer's fire fighter one structure class has seen a lack of participation, the new recruits were informed they must call within 24 hours of not making it to the class. If they continue not to attend we will be asking for their resignation.

All the 2014 red card class information has been submitted to DNR, they will let me know who still needs the NIMS 700 class and what other info or training is needed to red card our people.

2014 MOB list is out and it looks like we have some prime spots, with the modification to 3891 "The mob truck" the crew is excited to take it out on fire. As for the BLM, they contracted two pieces of equipment, looks like will be getting a check for around \$2,300 subtract crew wages from that. Peter has all the crews' time sheets and equipment red dogs. We still need to submit that bill to BLM. At this time."

The Board did discuss the need for three new radios and agreed that the Chief should go ahead and purchase them as pieces of vital equipment.
